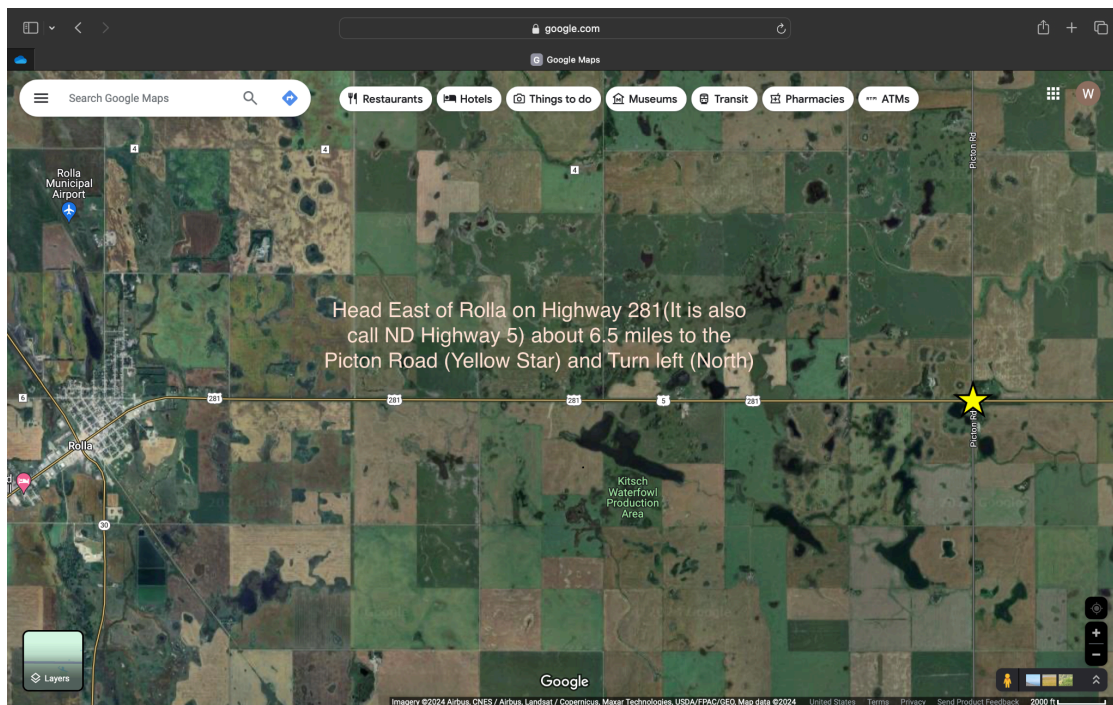

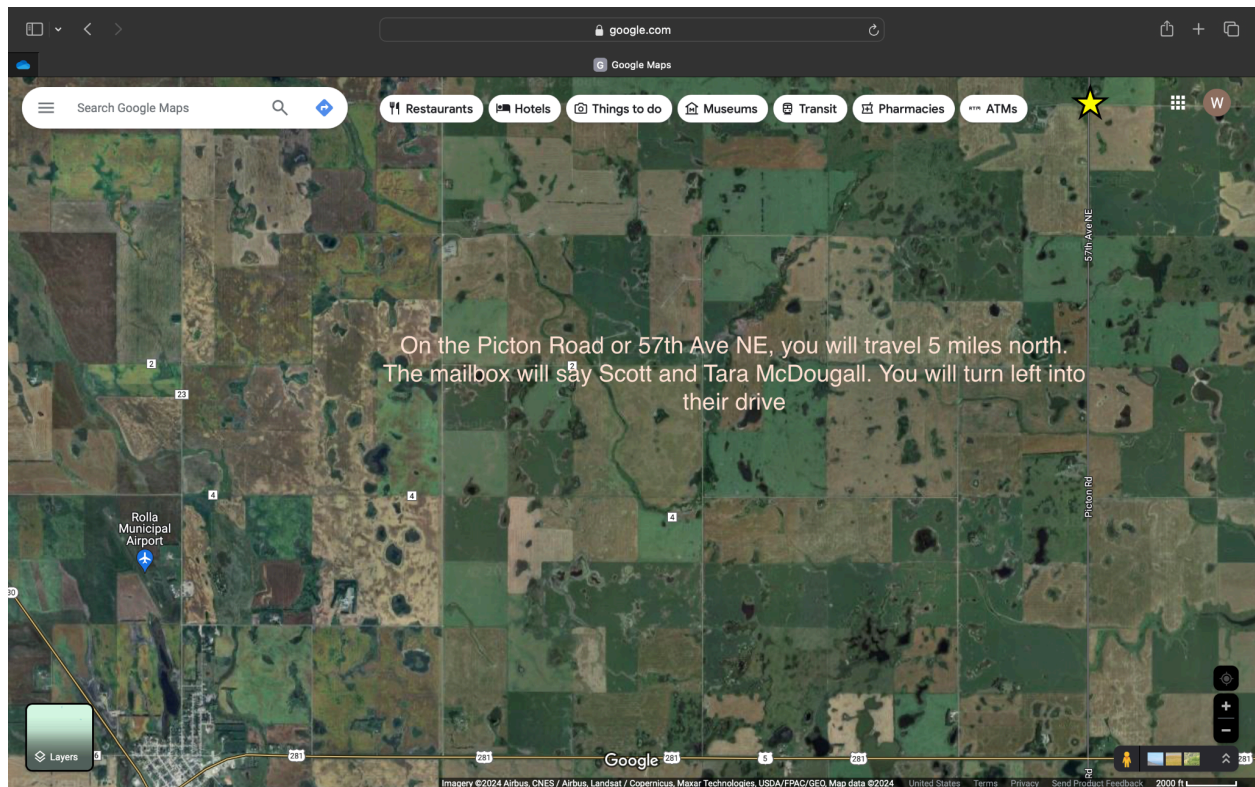
## Directions to the Practice Pits

The following will be directions to the practice pits for land judging. Before I give directions, I have provided some overall notes.

1. Scott and Tara McDougall will be hosting the practice and contest sites
2. They live east of Rolla in Towner County. Tower County does not mark their roads.
3. The materials for the practice pits can be picked up at the Rolla School. You can use the main doors (Door #1). The doors are clearly marked

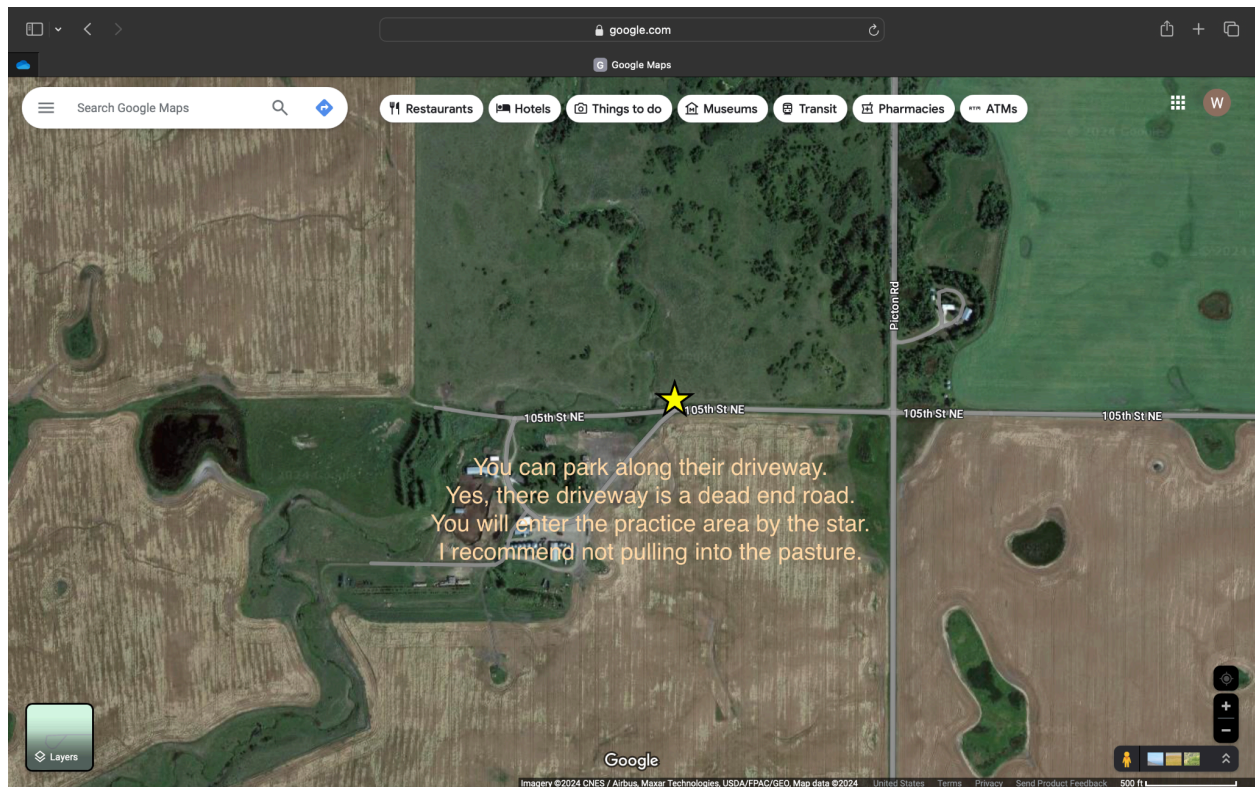


1. You will drive East of Rolla on Highway 281 or ND Highway 5 (these are the same road) about 6.5 miles. You will turn left (North) on the Picton Road or 57th Ave NE. I will put a sign
2. Side note: If you turn Right you will go to Perth. You don't want to go to Perth.



3. On the Picton or 57th Ave NE gravel road, you will go 5 miles to the McDougall Farm
4. Their name is on the mailbox. You will turn left into the drive.
5. This road can be bad if it recently rained. I recommend not driving like a race car driver.





6. Once you are on the driveway or dead end road, you will drive to where the road splits. The entrance to the practice pits are at the split.
7. Don't drive into the practice pits area. You can park along the driveway.
