Entry of Static Exhibits at the NDSF is <u>Wednesday</u> from 10:00 am to 6:00 pm and <u>Thursday</u> from 8:00 am to 12:00 pm. Judging of static exhibits will begin at 1:00 pm on Thursday.

Entry of Horticulture exhibits at the NDSF is <u>Wednesday</u> from 10:00 am to 6:00 pm and <u>Thursday</u> from 8:00 am to 11:00 am. Judging of Horticulture exhibits begin at 8:00 am on Thursday.

Ribbon & Point appeals must be made to the Division Superintendent within 24 hours of Judging of the Exhibit.

Division superintendents and assistant superintendents are <u>required</u> to be at the NDSF during the scheduled times on <u>Wednesday</u> and <u>Thursday</u>.

Division Assistants attendance is <u>required</u> on <u>Thursday</u> and maybe required on <u>Wednesday</u> (dependent upon Superintendents Expectations/Needs based upon specific division needs).

Entry of Horticulture exhibits at the NDSF is <u>Wednesday</u> from 10:00 am to 6:00 pm and <u>Thursday</u> from 8:00 am to 11:00 am. Judging of Horticulture exhibits begin at 8:00 am on Thursday.

All Horticulture Division Assistants must be at the NDSF before 8:00 am on <u>Thursday</u> to assist with organization of exhibits and judging process. This includes arranging of plants upon entry, judging, scanning, tabulations, and ribbon placement.

Superintendent and Assistant Superintendents are required to work on <u>Wednesday</u> with display, organization, and quality checking of plants. Some Division Assistants will need to arrive on Wednesday based upon Superintendent and Assistant Superintendent directions to assist with quality check and entry.

All exhibits will go through a quality check point following the criteria in the "FFA Activities & Premium List" before being placed on tables by their designated classes. If the plants do not meet the quality standards, they will not be allowed in the NDSF Lower Atrium and must be taken home or disposed of in the dumpster. ND FFA does not want volunteers to arrive on Thursday morning to judge plants that are not free of weeds, diseases, insects, and insect damage or exhibits not meeting the entry requirements.
