Purpose

The purpose of the FFA Demonstration Leadership Development Event is to provide students in grades 10 and below an opportunity to develop leadership and communication skills by presenting an agricultural process or skill through a structured, hands-on demonstration. Participants learn to organize ideas, explain concepts clearly, and utilize visual aids or materials to educate others about a topic in agriculture or agricultural education. The event encourages creativity, enhances public speaking, and promotes agricultural literacy by requiring students to demonstrate real-world applications of agricultural knowledge. In alignment with the Agriculture, Food and Natural Resources (AFNR) Cluster Skills and Career Readiness Practice Standards, this event supports early career development and helps students gain confidence and competency in presenting agricultural content.

Objectives

- 1. Offer leadership development training to members.
- 2. Promote and inform the public about the many facets of the agricultural education instructional program.
- 3. Provide an exchange of improved ideas, methods and techniques among the chapters within the district.
- 4. Add to the interest and involvement of the members at the District Leadership Meetings.
- 5. Be a normal and natural outgrowth of the instructional program in agricultural education.
- 6. A demonstration must involve actual materials and/or illustrations.

DISTRICTS

Event Rules & Format

The Demonstration events are held at the District Leadership Meetings and State LDE Day.

Each chapter may enter one demonstration at the District level. The number of members involved shall be determined by the chapter but must not be more than three.

Demonstrations are to be between 5 and 15 minutes in length. Eight points will be deducted from the contestants score for each minute (or major fraction thereof) under or exceeding this time limit.

Contest Eligibility

- 1. To be eligible to participate the student must be enrolled in an agricultural education course and appear on the chapter FFA membership roster.
- 2. Participants in the Demonstration event must be 10th grade or younger.

All demonstrations must be of an agricultural nature or be related to some facet of agricultural education/FFA. Demonstrations must demonstrate some skill or process related to agriculture/agricultural education. No live animals may be used for demonstration purposes.

Event Rules & Format
